B. Introduction of New Board Members

Dr. Joyce Jarrett welcomed everyone to our new meeting space in the Hampton IV Building and to the first College Board meeting of the academic year. Dr. Jarrett welcomed the two new board members (Mr. Andrew Crawford and Mr. Stephen Ferguson) both representing the city of Newport News.

Mr. Crawford shared that he learned to ride a motorcycle at Virginia Peninsula Community College (VPCC) and has worked in Higher Education for his career. Mr. Crawford is a systems thinker and hopes to share that while serving on the VPCC College Board.

Mr. Ferguson served 20 years in the fire department and is now a business owner. He is interested in giving back to his community and will apply his talents and knowledge to help the college as well as the community. Mr. Ferguson is a numbers person and is looking forward to learning how he can give back.

C. Report from the College Board Liaison to the Thomas Nelson Educational Foundation Board of Directors

Mr. Allan Melton was unable to attend the board meeting and provided a copy of the Educational Foundation Board meeting notes from the June 15, 2023, meeting for the College Board's review. The Thomas Nelson Education Foundation Inc. is now officially the Virginia Peninsula Educational Foundation, Inc.

3. PRESIDENTS REPORT

A. Introduction of New College Leaders

Prior to introducing our new college leaders Dr. Brannon extended her thanks to the College Board and acknowledged her Cabinet members and Deans for their support throughout the summer during the unexpected loss of her younger sister.

Dr. Brannon introduced Ms. Daniela Cigularova, Vice President for Enrollment Management and Student Success. Daniela joined us from ODU and is connected to many throughout the state. Daniela introduced Ms. Tiyé Smith, SGA President who is a Visual Arts major with many ideas.

Dr. Kerry Ragno introduced new members of her team Dr. Scott Stauble, Dean of STEM, Ms. Nicole Courier, Dean of ABHS and Dr. Joseph Fairchild, Associate Vice President for Academic Affairs.

Dr. Burge Hall was introduced as the Dean for Retention and Student Success.

Mr. Steven Felker was introduced as the new Vice President for Institutional Effectiveness and Transformation. Mr. Felker oversees IRE, HR, Marketing, and the Development Team.

Mr. Felker introduced Mr. Eric Pesola, Director of Marketing and College Relations.

B. SACSCOC Self Evaluation

Mr. Felker provided a presentation on the SACSCOC self-evaluation process and shared that the College is two years out for a reaffirmation visit which will encompass a great deal of work ahead of us this year.

Mr. Felker highlighted and walked through the principles of accreditation and discussed the role of the governing board.

The self-evaluation piece is the most important item that needs to be focused on currently and will become a part of the College Board Policy Manual. A sub-committee or task force led by Mr. Felker should be formed to complete this work. The goal is to spend the fall of 2023 working through the process and be ready to implement it in the spring of 2024 and have the

first self-evaluation process by October of 2024. An evaluation process is required to be in place for SACSCOC.

C. Acknowledgement and Discussion of the College Goals and Expected Outcomes for Current Year.

During the summer the President's Cabinet participated in a retreat and four focus areas were determined and identified for the College (Enrollment and Retention, Organizational Effectiveness, Capacity Building, and Culture Development). In the September President's report, the President's annual goals are included on pages seven and eight. These goals align with the four focus areas and should be used for the evaluation of Dr. Brannon for this year.

A fuller discussion and feedback on the goals will be discussed in closed session.

D. Written President's Report to the College Board

Dr. Brannon shared information and elaborated on her trip this summer to Stuttgart, Germany. The trip to Stuttgart explored the dual-track vocational education and training program known as VET, a talent development pipeline. The pipeline is very successful and supports approximately 1.3 million apprentices a year. The local delegation that visited Germany this summer is now looking into a pilot program for our local area.

Ms. Bunting shared that the AOH is looking at expanding their summer internships to a year-long program and could be an avenue to pilot this type of program.

Dr. Jarrett expressed interest in the "Swamping the Schools" initiative and shared that it was a great way to get information to prospective students. It was suggested that surveying fall enrollees about their first contact or interaction with the College prior to enrolling would be helpful information to know.

Dr. Romero applauded Dr. Hollins for all the work that she has done over the last 18 months.
