APPROVAL OF MINUTES

Chair McMillan welcomed everyone to the meeting.

Mr. McMillan welcomed the new members and asked the other members to introduce themselves.

Report from the College Board Liaison to the Thomas Nelson Educational Foundation Board of Directors

Mr. Michael Kuhns, College Board Liaison to the Educational Foundation, reported on the following items:

During its June meeting, the Foundation approved a three-year strategic plan for development, which is designed to significantly increase fund raising on behalf of the College. The strategic plan is the culmination of approximately seven months of work by the Development Team in collaboration with Tricia Hudson, who is serving as consultant to the project. In addition to increased fund raising goals for the next three years, the approved plan includes staffing needed to implement the fund raising strategies. One of the items identified in the strategic plan is the need to develop a comprehensive vision for the College that identifies programs and services that can benefit from private support.

A full report on the development strategic plan will be presented at the College Board meeting in December.

The Foundation has launched its 2017-18 annual fund raising campaign with a goal of \$665,000. The internal campaign goal is \$60,000, which includes gifts from faculty, staff, administrators, and College Board members. The Foundation appreciates and relies on support from the College Board in fund raising for Thomas Nelson. This year, the goal for College Board giving is set at \$7,000. Mr. Kuhns asked Board members to see Vice President Cynthia Callaway for more information on how to make their annual gift to the Foundation.

Mr. Kuhns reported that the Foundation held its ninth annual car show to benefit the College's Automotive Technology Program on Saturday, August 26. He noted that POMOCO, Dominion Energy, and Old Point National Bank sponsored the event. Mr. Kuhns thanked everyone who came out to enjoy the day on the Hampton Campus, and he reported that planning has already begun for next year's 10th anniversary Car Show event scheduled for Saturday, August 25, 2018.

Ms. Callaway shared that the Newport News State of the City Address will be held on October 3, 2017, at the Newport News Marriott at City Center, 12:00 Noon - 1:30 p.m.

Ms. Callaway shared that the City of Hampton State of the City Address will be held on October 31, 2017, at the Hampton Roads Convention Center, 12:00 Noon - 1:30 p.m.

Ms. Callaway asked Board members to contact Ms. Elliott to express their interest in attending these events.

FINANCE AND MUNICIPAL LIAISON COMMITTEE

On behalf of the Finance and Municipal Liaison Committee Chair Leonard Sledge, Mr. Michael Kuhns presented the following committee report and recommendations:

A. Approval of April 26, 2017 Minutes

The Committee moved that the Thomas Nelson Community College Board approve the Finance and Municipal Liaison Committee meeting minutes from April 26, 2017, as presented.

B. Review and accept for record purposes the Draft FY 2017 Year-end Local Funds Financial Statement

C. Approval of Resolutions: Deed of Easement-City of Hampton, Virginia Mr. Charles Nurnberger, Vice President for Finance and Administration reported that Thomas Nelson Community College is committed to ensuring that its roadways and facilities comply with all federal and state environmental regulatory requirements. He reported that the City of Hampton is requesting access to a drainage ditch coming onto the campus in multiple locations. Once approved by the board, the resolution will be forwarded to the State Board for Community Colleges to act upon in December.

The Committee moved that the Thomas Nelson Community College Board approve the Deed of Easement to the City of Hampton, Virginia, as presented.

CURRICULUM, INSTRUCTION, AND STUDENT SERVICES COMMITTEE

Ms. Elizabeth Tai, Chair of the Curriculum, Instruction, and Student Services Committee, presented the following committee report:

A. Review of Meeting Minutes from April 26, 2017

The Committee moved that the Thomas Nelson Community College Board approve the Curriculum, Instruction, and Student Services Committee meeting minutes from April 26, 2017, as presented.

The motion was approved.

B. Proposed discontinuance of the Financial Management Career Studies Certificate (CSC) This CSC has been specifically vetted through Ferguson, the company for which the program was initiated. Due to the number of qualified applicants exceeding the employment demand, the proposal is to discontinue the program due to low enrollment.

The Committee moved that the Thomas Nelson Community College Board approve the discontinuance of the Financial Management Career Studies Certificate (CSC) as presented.

The motion was approved.

C. Proposed Small Unmanned Aircraft Systems (sUAS) Flight Technician Career Studies Certificate (CSC)

The Flight Technician Career Studies Certificate prepares students to fly and maintain a sUAS and earn the Federal Aviation Administration Part 107 certificate. Courses in the nine-credit-hour program can be used as electives in the Associate of Applied Science in Information Systems Technology or the Associate of Applied Science in Mechanical Engineering Technology programs for students graduating with an A.A.S. degree and a career studies certificate. Graduates from the sUAS Flight Technician CSC program are in demand by many industries. The potential commercial uses of unmanned aircraft systems include remote sensing of the atmosphere; disaster response; police and fire response; weather forecasting; scientific research; agricultural survey of crops, soils, and livestock; crop dusting; wildfire surveillance; wildlife surveys; power line and pipeline survey; industrial security; oil, gas, and mineral exploration; and more.

The Committee moved that the Thomas Nelson Community College Board approve the proposed Small Unmanned Aircraft Systems (sUAS) Flight Technician Career Studies Certificate (CSC), as presented.

D. Proposed Associate of Science in Health Science

The A.S. degree in Health Sciences will afford a more seamless transfer to fouryear schools for Bachelor of Science in Health Science and related health professions programs. The degree prepares students for careers in public health, exercise science, and pre-clinical health specialties such as occupational and physical therapy. The demand for health science-related careers is growing. Through 2021, jobs are projected to increase by seven percent on the Virginia Peninsula and 12 percent across Virginia. Occupations in public health and exercise science include dietitians, nutritionists, physician assistants, athletic trainers, physical therapists/assistants, and occupational therapists/assistants.

The Committee moved that the Thomas Nelson Community College Board approve the proposed Associate of Science in Health Science, as presented.

The motion was approved.

PRESIDENT'S REPORT

In association with various Cabinet members and staff, President Dever provided reports and updates on the following items:

Enrollment Report

Ms. Kris Rarig, Interim Vice President for Student Affairs, presented the enrollment report with the following key points:

Summer 2017 vs. Summer 2016

- > FTE enrollment was down 15.8% from Summer 2016
- ► Headcount was down 11.2% from Summer 2016

Fall 2017 vs. Fall 2016

- > FTE enrollment is down 10.9% from Fall 2016, as of September 27, 2017.
- Headcount is down 10.8% from Fall 2016, as of September 27, 2017.

Ms. Rarig reported on the 10-year enrollment patterns at Thomas Nelson. She listed specific efforts that the College is undertaking to increase enrollment. She reiterated that the College is continually engaged in seeking ways to manage enrollment.

Financial Status of College

In conjunction with Vice President Nurnberger, Dr. Dever reviewed the financial status of the College as previously communicated through messages to the College community and his address on All College Day. Over the past ten years, enrollment climbed strongly during the 2007-2012

Elliott, Recorder Distribution: Administrators, Archives, Chancellor Page | 6 period associated with the Great Recession and subsequently declined at a comparable rate during the 2012-2017 period associated with a recovering economy. This general pattern has occurred with community colleges across Virginia and the nation. The decline is continuing with the 2017-2018 academic year. Since the major source of revenue is tuition and fees, the College is experiencing significant financial constraints, with the deficit in revenue projected to be over \$4,500,000. Significant steps have been taken to reduce expenditures, to include holding a number of vacancies unfilled, limiting travel, and decreasing a number of budgets. Various structural changes, to include the elimination of some positions, are also being considered and incrementally implemented to ensure that the organization functions at a maximum level of efficiency and effectiveness. At the same time, major efforts are underway in all areas of the College to reverse the decline in enrollment and to ensure that we are meeting the educational and workforce training needs of the Virginia Peninsula.

2017-2018 College-wide Outcomes

Dr. Dever shared that each year the College engages in a process of identifying the most critical areas of focus in advancing the goals of the Thomas Nelson strategic plan, *Focus 2020*, and the Virginia Community College System strategic plan, *Complete 2021*. He reported that this year's efforts began with a planning retreat that was held on June 29, and culminated in the adoption of 13 College-wide outcomes for the 2017-2018 year in early September. Dr. Dever then introduced the College's Director of Institutional Research and Effectiveness, Mr. Steven Felker, who provided a presentation to the Board.

Mr. Felker's presentation began with an overview of the institutional effectiveness framework at the College, which includes both a 5-year strategic planning cycle and an annual assessment and evaluation cycle. As part of the overview, Mr. Felker noted the College's efforts over the past several years to both focus its annual College-wide outcomes and elevate those outcomes. This has been accomplished by reducing the number of outcomes the College commits to each year and, for those to which it does commit, emphasizing the desired impact of the College's efforts in those areas, setting clear indicators by which achievement will be evaluated, and identifying supporting strategies.

For the 2017-2018 year, Thomas Nelson has committed to 13 College-wide outcomes. Mr. Felker summarized each of those outcomes for the Board and spoke to the information the College had used to establish them as top priorities. Under the College's goal of *Student Success*, the three outcomes focus on onboarding and guiding students, scheduling and course availability, and student growth and development. For the College's *Community Partnership* goal, the three outcomes focus on high school dual enrollment, college identity and value, and student and employer engagement. Under the third and final College goal of *Institutional Excellence*, the three outcomes focus on campus construction and physical space planning, institutional climate, and instructional technology. For the VCCS goal of *Tripling of Credentials*, Thomas Nelson's four outcomes focus on the key student success areas of college-level math completion, student retention and progression, and credential completion, as well as on efforts related to the Workforce Credentials Grant. Mr. Felker noted that a many of the outcomes for 2017-2018 are continuations of major efforts from 2016-2017.

Dr. Dever reported that achievement of these outcomes will require full commitment and efforts from the College community as a whole.

Accreditation

Dr. Dever noted for the record that, as previously communicated to the College community by email message, Thomas Nelson had received in July official word from the President of the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC) that the Commission had reviewed the latest monitoring report and required no further report from the College. Under the direction of the Academic Assessment Committee, College faculty have worked extensively to demonstrate full compliance with Comprehensive Standard 3.3.1.1, Institutional Effectiveness for Educational Programs. It is gratifying to see their efforts validated by this SACSCOC review. The next major requirement for maintaining our accreditation will be preparing and submitting the Fifth Year Report due in September 2021.
