C. Report from the College Board Liaison to the Thomas Nelson Educational Foundation Board of Directors.

Mr. John McMillan, Jr., College Board Liaison to the Thomas Nelson Educational Foundation Board of Directors, provided a report from the December 14, 2017, Foundation Board meeting.

Dr. Susan English presented an update to the Educational Foundation on current and upcoming Academic Affairs initiatives.

Ms. Tricia Hudson, who has been engaged by the Foundation as a consultant for implementation of the 3-year development strategic plan, provided a 6-month update on that plan. Her update included a review of the revised development Vision document that was reviewed at the December College Board meeting and a preliminary review of a \$16 million "project list" of College growth and enhancement opportunities for funding proposal requests. The project list identifies what program funds are needed to accompany the Vision project.

The Foundation voted to honor Continental Automotive Systems, Inc., as the College's honoree for the 2018 Chancellor's Leadership in Philanthropy Award. The award will be presented during the annual luncheon on April 17 in Richmond.

Appreciation for service was expressed to several outgoing Foundation members as well as to several Foundation members reappointed to new terms. Outgoing Foundation President, Mr. Ross Mugler, was recognized and thanked for his service. The Foundation Board elected Mr. William Grace as the new Educational Foundation President and Rick Gallaer as the new Educational Foundation Vice President.

The next Foundation Board meeting will be held on March 15, 2018.

Mr. McMillan reported that as of February 12, 2018, the Educational Foundation's 2017-2018 Annual Giving Campaign had raised \$464,576, or 68% of its annual goal of \$665,500. He also stated that the College Board has a goal of 100% participation in the annual fund drive, but the goal has not been reached yet. He thanked the College Board members who have already contributed and urged those who have not to step up and help achieve the participation goal.

D. Additional Item

Dr. Dever introduced Dr. Jennifer Martin, Professor of Biology, who is a recipient of the State Council of Higher Education for Virginia (SCHEV) 2018 Virginia Outstanding Faculty Award, which is the highest faculty award in the Commonwealth.

Dr. English commented that Professor Martin is an award-winning educator and scientific researcher who is actively engaged with students in the classroom and in the field. Dr. Martin facilitates student success and uses student-centered experiences for recruitment and retention of students in STEM fields. She is acknowledged for her outstanding teaching and dedication by her faculty colleagues at the College.

She has been happy to teach our students and provide them with field experience while still being able to pursue research on oceanic fishes at various international locations. She specifically expressed her love for the Oarfish, which is the longest fish in the sea.

Mr. Harper thanked Dr. Martin for her dedication to Thomas Nelson and our students.

III. FINANCE AND MUNICIPAL LIAISON COMMITTEE

On behalf of the Finance and Municipal Liaison Committee, Chair Reese provided the following committee report and recommendations:

A. Approval of December 6, 2017 Minutes

Mr. VanVoorhees noted an inadvertent omission of his name in the list of attendees for the members present at the December 6, 2017, Finance and Municipal Liaison Committee meeting. Ms. Reese stated that the correction will be made.

The motion was approved.

B. Approval of Resolution: Increase in Student Fees for FY 2019

The Committee moved that the Thomas Nelson Community College Board approve the Resolution for Increase in Student Fees for FY 2019, as presented.

Ms. Reese stated that the Student Government Association has been apprised of the proposed increase, and if approved by the College Board, final approval would be needed by the State Board before implementation of the \$0.50 increase in 2019.

Mr. McMillan inquired as to how this increase compared to those in previous years. Mr. Nurnberger stated that the proposed \$0.50 increase is consistent with previous years and that the increase will enhance student life at both campuses of the College.

The motion was approved.

Ms. Reese noted that the Committee also discussed the new traffic signal at the junction of Thomas Nelson Drive and Hastings Drive, as well as an update on the campus digital sign. Discussions are underway with the City of Hampton and the Virginia Department of Transportation to expedite the digital sign project.

IV. CURRICULUM, INSTRUCTION, AND STUDENT SERVICES COMMITTEE

On behalf of the Curriculum, Instruction, and Student Services Committee, Chair Owens presented the following committee report and recommendations:

B. Faculty Emeritus: Dr. Roy Hyle

The Committee moved that the Thomas Nelson Community College Board bestow the honorary title of Professor Emeritus on Dr. Roy Hyle, retired Professor of Biology.

Mr. Owens stated that the Professor Emeritus award is the highest award at Thomas Nelson for honoring faculty for meritorious service to the College.

Mr. McMillan noted two letters of recommendation for Dr. Hyle by the Appointments Advisory Committee, one of which was provided by Dr. Jennifer Martin.

The motion was approved.

V. PRESIDENT'S REPORT

In association with various Cabinet members and staff, President Dever provided reports and updates on the following items:

A. Introduction of Director of Human Resources, Dr. Lynda Byrd-Poller

Dr. Dever introduced the newest member of the President's Cabinet, Dr. Lynda Byrd-Poller, Director of Human Resources.

Dr. Byrd-Poller started as Human Resources Director on February 12, 2018. Dr. Byrd-Poller served as Director of Human Resources, Strategic Planning & Professional Learning for Charles City County Public Schools. She has held previous teaching and administrative positions with Williamsburg-James City County Public Schools. Her academic background includes a bachelor's degree from Hampton University, a master's degree from Regent University, and a doctorate in Human and Organizational Learning from George Washington University.

B. Enrollment Report

Ms. Rarig, Interim Vice President for Student Affairs, presented the enrollment report.

Spring 2018 FTES enrollment is 4,146, which is 8.8 % lower than Spring 2017 at 4,544 FTES. Spring 2018 Headcount is 7,237, which is 9.8% lower than Spring 2017 at 8,024.

She also provided comparative data on Dual Enrollment for Spring 2017 and Spring 2018 to date, which was requested by Ms. Bunting at the December 6, 2017 College Board meeting.

Ms. Rarig discussed the ongoing work of the Select Committee on Enrollment. The Committee has been charged to solicit ideas—whether large or small—from the College community and its own membership for turning around our current enrollment trajectory. The emphasis is on creativity and innovation. These may involve suggestions for new ways of operation, new organizational structures, new communications strategies, new programs, new ways of offering classes, and anything else that may help put the College back on the path of enrollment growth in response to student and community needs.

C. Workforce Development Report

Dr. Dever announced that Dr. Deborah Wright, Vice President for Workforce Development, will be retiring from the College at the end of March 2018. Dr. Wright is the Founding Vice President for Workforce Development at Thomas Nelson and has served the College since 2000.

Dr. Wright provided a PowerPoint presentation on the inception and progression of Workforce Development at Thomas Nelson over its history. Dr. Wright commended the Workforce staff for their dedication to advance the mission of the College and in service to the needs of the Peninsula.

Dr. Wright introduced Mr. Jerry Hemenway, Corporate Training and Workforce Services. Mr. Hemenway invited a former student, Mr. Shawn Hall, who shared his experience on how the workforce training and opportunities provided by Workforce Development at the College has changed his life. Mr. Hall is currently employed at Bay Electric using the skills that he obtained.

Dr. Dever and the College Board thanked Dr. Wright for her many dedicated years to Thomas Nelson and specifically to Workforce Development. Dr. Dever stated that a formal recognition of her services will be held on March 29, 2018, at a retirement celebration in her honor.

D. 2018 Legislative Update

Ms. Callaway provided copies of House Joint Resolution No. 212 and Senate Joint Resolution No. 126. The Resolutions commend Thomas Nelson Community College for its founding in 1967 as the first community college on the Virginia Peninsula and Tidewater regions. The Resolutions were read in the House and Senate Chambers at the 2018 Legislative Session on February 5, 2018.

Ms. Callaway stated that several events are being planned in honor of the College's 50th Anniversary over the next year. Ms. Callaway provided copies of a book cover by Arcadia Publishing Company. The company is in the process of publishing a book on Thomas Nelson Community College as part of its Campus History Series.

F. Symposium on Career and Technical Education

Dr. Dever informed Cabinet of The Case for Career & Technical Education Symposium that will be held on April 23, 2018, at the Hampton Campus. The symposium will bring together employers, educators, and others concerned with ensuring a strong linkage between educational attainment and the economic needs of the Virginia Peninsula and greater Hampton Roads. Letters of invitation will be sent out in the coming weeks. College Board members were asked to note the event on their calendars.

Ms. Bunting inquired about videotaping the symposium for use as an education tool for the school systems. Ms. Callaway stated that she would ensure that the symposium would be taped.
